"Living With AIDS" Panel Touches Albright

A panel discussion entitled "Living With was held last Wednesday evening in the South Lounge. William Bender, Board Chair of Berks AIDS Health Crisis, led the discussion with four people who were either P.W.A.'s (Person With AIDS) or HIV (Human Immunodeficiency Virus) positive. Over 150 students and faculty attended this event, the motivation for many being just to satisfy curiosity and see what someone with AIDS looks like, and/or to get Experience credit. Whatever the reason, this nearly two-hour event proved to be extremely informative. moving, and yet humorous at times.

THe panelists spoke at Albright because they wanted to get a crucial message out to college students, who are consequently the next biggest risk group for acquiring the virus. Their message to the audience was to learn about AIDS, help the cause by informing others about the facts, and to be cautious in their behavior. One panelist named Michael felt that it was important for people to "know that they [P.W.A.'s] are not like Freddy Krueger:"

Another message that came across was that having the virus is frightening and can make you rather lonely. Michael said that it is frightening because "people who are unaware [of the facts] don't want to be around you." He later described the loneliness and the negative image others have of P.W.A.'s when he said, "It's like we're the black licorice, and everyone wants the red." Although all of the panelists have acquired

the virus in some way, each is a unique individual with different circumstances and problems. It is often a fault of the general public to group people with the virus as "AIDS freaks" or as "people dying with AIDS." To those who attended the discussion, it is evident that this is truly not the case. The panelists appeared lively and healthy. The audience listened to a different story from each of the panelists, revealing how they acquired their illness, the nature of their ess, and how they are living and coping

One of the panelists, Eva, gave an especially touching story. She told of her initial shock when she was tested positive. "It couldn't be me," she thought, since she does not fit into any of the "risk groups." Eva acquired the virus via her husband, who passed away after three years of living with AIDS. Eva is left to care for four children. Two of Eva's children were born after she acquired the virus; one was tested positive, the other, negative.

Another panelist, Steve, had his entire family tested for AIDS, and only his wife was positive. Steve told us over and over of the remendous feeling of guilt he has for passing the virus on to his wife. Now Steve and his wife have a rather positive attitude about their lives. They are actively trying to inform the public of the facts about the virus, particularly the Spanish speaking community who are uneducated about AIDS. Steve told the audience that he himself was completely ignorant of AIDS when he was tested positive in 1986. He learned about it through health agencies and has since drastically changed his living habits to "try to stay as healthy as

Barney, after living with ARC (AIDS Related Complex) for 5 years, has also changed his perspective on life. The way he sees it, 'everybody is gonna die, so don't be afraid to get to know an AIDS victim just because they might die." Barney's father once described a bridge to him this way: "We build them to keep people together." He hopes that more bridges will be built between P.W.A.'s and the public in the near future.

In response to a question asked by a student of what the students and anyone who cares can do to help out, Barney said, "The best thing you could do is, whenever you hear someone talking ignorantly about AIDS, correct them." Just spreading the word will help rid the loneliness; the more informed people are, the less frightened they will be to become friendly with a P.W.A.

Mr. Bender added other ways people can et involved including the following: helping with the AIDS hotline, handing out pamphlets and informational brochures, doing paperwork, or getting trained to participate in the Buddy If you would like to learn more about AIDS or how you can help, ask a friend who attended the panel discussion, or contact the Berks AIDS Health Crisis at (215) 375-2242, or write to P.O. Judiciary Board Renders Decision

On Tuesday, December 12th, the Judiaciary Board rendered their decision on the Reynods/ Crawl racial harrassment issue. The open hearing started at just past 7 PM, with the Judiciary Board Chairperson, Dr. Jeffrey Barker, reminding the audience that it was an "emotionally laden issue," and that interruptions by the audience interfering with the hearing would not be tolerated. Barker continued to state that the burden of proof was on the party bringing the charges. which was the Dean of Students.

Reynolds, a freshman, was charged with incident of racial harrasment, brought against him by the Dean of Students, and was appealing the issue of racial harrasment and the punishment offered by the Dean. The punishment under appeal consists of suspension from the 1990 Interim, Disciplinary Probation for the remainder of the academic year, educational programming, and relocation of

Dale Vandersall, Dean of Students proceeded to give testimony that the alleged incident of racial harassment was reported to the Student Affairs Disciplinary Staff by Duane Crawl, on November 28th, by way of an incident report. Of the three incidents reported to the Disciplinary Board, two were confirmed by the defendent. The Disciplinary Board's decision was based on two premises: to indicate how important the issues were, and the feelings that counseling or educational programing would be beneficial.

The outcome of the hearing provided Reynolds with two options. His first choice was to accept the disciplinary actions provided by the Dean. The Judiciary Board arrived at an alternative option, consisting of disciplinary probation and an extensive informational

research paper dealing with the topic of racism.

Dean Vandersall felt that the hearing went "very well" and that the "Judiciary Board process is important process for us, and that it is and educational forum for all." Dr. Jeffery Barker, chairperson of the Judiciary Board, stated that he, as well as the Judiciary Board, opposed all forms of racism. Barker stated that the hearing went well and, "that it was a good process." Barker felt it was both "fair and educational" in that it informed everyone of the "various facts."

Open Forum Discusses Problems

On Wednesday, December 13th, a forum was held in the South Lounge to discuss recent issues brought up in the latest edition of the Albrightian (Dec. 8, 1989). The forum, run by Dale Vandersall - Dean of Students, and Eugene Lubt - Academic Dean, and attended by well over 100 people, including students and faculty members.

The object of the forum was to clear up

the "distortions and misinformation" which reportedly plagued the latest issue of the Albrightian, specifically in its editorial. In his opening comments, Vandersall felt that what was printed in the editorial "could create some real polarization in the community...we want to find a way to mend that, because community spirit is too important

Vandersall first addressed the part in the Vandersall first addressed the part in the editorial which accused the administration of deliberately witholding information from the students. Vandersall disagreed, stating that administration is "very open to any student who wants to gain appropriate information." He added that information would not, and will not, be given out in cases where judicial actions are still under way, or in which the students involved want the information to remain confidential.

The second reference Vandersall made to the editorial concerned the writer's use of the "facts" reported in two separate incidents of harassment. He stated that the editorial

that other "facts" stated in the editorial were incorrect and distorted. He stated that "it is very important that we check the facts out before we start putting these kinds of things together, and we think about what the implications are." He also said he felt that this type of misinformation would not be a problem again in the newspaper.

Dean Lubot opened by saying that "this meeting is to give you a chance to ask any questions you might want to ask, and raise any issue you want," hoping that the air

Lubot spoke about the college's task to create a multi-cultural community, and that, this is not an easy task to accomplish; there always comes a point of crisis, and perhaps we have reached that point. This is not unique in the history of colleges that try to create multi-cultural societies. We must work through this point."

Dr. Jeff Woodward, faculty chairperson, addressed the audience next. He said that diversity was not the issue on this campus, and that it was important for us all to know the college's stance on the issue. "We believe, the college's stance on the issue. "We believe, and we have believed, that it is essential to welcome people of different backgrounds, different races, different creeds, and different lifestyles. This means that the college is committed to including and welcoming different kinds of people into the social fabric of the college. This last incident is a kind of

Woodward sated that the question was not "do was o it?" (diversify), but instead 'how can we do it and make people work collectively and positively with one another?

Diere was a large amount of student put at the forum, and the issues which were brought up varied greatly. Among the topics vere: the editorial in the Albrightian; Orientation and the letter which went out to students involved regarding the new program; the racial incidents which have been reported to the school and the rumors which have spread; SGA and their feelings towards administration; alledged inconsistencies in adminstrative actions; the Crowell Hall fire and the safety issue attached to it; the President's Christmas dinner being held at the Berks Country Club and its implications to the students on the issue of diversity; Albright Jnity; and the overall lack of input the students feel they have at Albright.

After more than two hours of discussion, heated at times, it was agreed between those present at the forum that better communication is needed between administration, faculty, staff, and students, so that rumors and gossip can be stopped. It was suggested that administration write through the Albrightian administration with the disciplination of the Albright community know what is happening on campus. Also, administration plans to meet with SGA bi-weekly in order to discuss student feedback on campus issues.

EDITORIAL

As Editor in Chief of the Albrightian, I have done my best to produce a newspaper which is informative, current, as well as entertaining. I have done this, with the help of my staff, to the best of my ability; yet also at the great expense of my personal time. In recent months we have all heard about many things (be they problems, concerns, situations) which are happening on and to our campus. It has been very difficult to [factually] incorporate these things into the paper so as to enlighten the Albright community of these things which they might not be aware of, but certainly should be concerned with.

Last week's editorial (NOT an article, as referred to by some) dealt with a sensitive issue -- thought by many to be too sensitive to be written about. As a result of this editorial, which was the **OPINION** of its writers (not necessarily facts, nor the opinion of Albright College or its community), the *Albrightian* and its editors have been questioned as to their motives, objectivity, responsibility, dependability, and perhaps sanity.

These accusations in themselves are unfair. To quote an administrator at last week's open forum, "We all make mistakes." Last week's editorial was not written to hurt anyone -- we are sorry if it did. It was not written to stir up controversy nor to inflame hostility toward any issues. It was not written to create the "monster" about which it spoke. It was written, however, in an attempt to raise an awareness about a great problem which exists on this campus. A problem which certainly plays a role in the tension which IS growing on this campus. It is communication, or a lack thereof, which is causing a problem of extreme proportion and is interfering with the functioning of our school.

We attend a small school where rumors run rampant. As the school newspaper, it is our job to report the precise happenings on the campus to the campus, and to do this as best we can. Sometimes in our "quest for the facts" or "hunt for the truth" we are stonewalled. Students complain that administration hides events which take place on the campus; administration says it must protect the "right to privacy." Miscommunication between the two exists. Memos/letters are sent to the students pertaining a certain issue; when asked for clarification, administration says something slightly different. Students complain of inconsistency; administration claims it was interpreted incorrectly. Miscommunication again.

The examples are endless but the problems stem from one thing—the need for greater communication between ALL individuals at Albright. Especially with all of the changes diversification brings to us, a solid network for communication is essential! More credit must be given to the students as to their willingness to accept diversity, and more credit must be given to the administration as to their motives for and intentions toward diversity. These understandings can only come about by the open communication of feelings and ideas.

Our school is in the midst of great change -- positive change -- but there are still some "bugs" which must be worked out along the way. Last week's open forum was the first step toward open communication on this campus. It was much needed. Let's **ALL** do our best to keep these lines of communication open, busy, and straightforward so as to promote true unity throughout our campus.



Letters to the Editor

Dear Editor,

This newspaper has recently published numerous articles that were directed towards the issue of racism, and more specifically, racism on this campus. These articles sparked a wave of responses that also addressed the problem. Unfortunately, it appears as though even the letters to the editor at Albright are divided along racial lines: white students write and state that they haven't seen or heard racism and prejudice (or in the worst of cases seem to support it) while the black students, and other minorities, describe to the readers the prejudices that are present. So crettably, I have the feeling that this tree leads many white students to the idea that Albright's minority students just for like they are being discriminated agains. Copefully, this letter will clear up any or sguided notions on this subject.

Racism (every prevalent at Albright. I hate to a onit that a large minority of the majority does not understand where race relacions, and in many areas of the country, where ideas about different groups of people have advanced to in the 1980's. As a white male, I am rarely if ever discriminated against. However, if a minority student had been in my shoes through the first four months of school, he/she would have heard or seen at least fifty racist statements or actions, the majority of which were directed towards black persons. Included in that group is the incident mentioned in "Tensions Mount on Campus" (the Albrightan, 8 December 1989). People should also realize that this problem is not limited to Albright College, for it has been documented on campuses around the country. However, the problem here does seem to be more prevalent than other campuses with which I am familiar.

As a final note, I would like to comment on a letter to the editor that appeared in last week's paper signed by the SGA. I don't know if this letter was sanctioned by the association as a whole or not, but if it was, I guess even our "leaders" don't understand the problem of racism. How can you be upset that a student received an "exceedingly harsh punishment" when it was the minimal punishment set forth for harassment? What I

want to know is why is the student still among us? Not that this would solve the bigger problem, but when a report of racism is officially documented and recognized and the students stays on campus, the administrators and students are giving the impression that they want racists on campus. The SGA also objected to the punishment because it did not follow the precedent set by a previous harassment case. Maybe the disciplinary board is finally trying to get things right. Now it is time for the rest of us to join them.

Last week's editorial attacking the school's policies on diversity raises serious questions in my mind about the integrity and responsibility of the editorial staff of the Albrichtian.

I believe that a college newspaper has every right to address controversial issues. It also has the obligation to take responsibility for its actions. Before the publication deadline I heard that the Albrightian was going to publish an article which would attempt to inflame campus opinion on an issue still in the judicial process. My information was certainly correct. The level of irresponsibility demonstrated by the writer of the Albrightian's editorial would have made it questionable as a letter to the editor; it is outrageous that the editorial appeared with the official sanction of the Albrightian editorial staff.

It was fundamentally unfair to print any article based on completely unsupported allegations of one party to a dispute. Having decided to print such an article, the editors should have insisted that the word "facts" not even be used in the article. The "facts" that the article cites are even more distorted that those brought to the Dean of Students by SGA representatives in a meeting at which I was present. At that time Tom Malecki and Cris Giambalvo were fully briefed on the case.

The "facts" in the article were not even alleged last evening a the Judiciary Board hearing by the defendant. I refer in particular to the charge that the white student had been

This past Thursday night the displaced residents of Crowell Hall came together for a Reunion Dinner with guest of honor, Henry DeTurk. The dinner was coordinated by second floor resident, Heather Reese and Dr. Tim Ring. Ring, the director of weekly support group meetings stated that Crowell Hall, as a community has rallied together and made great strides in recovering from Postraumatic Stress Disorder. "You deserve a lot of credit for what you went through and are going through."

Henry DeTurk, the security guard who discovered the fire, thanked everyone for the numerous phone calls and letters and stated, "Albright students are the greatest."

Following the dinner, Ring, R.D. Anna Maria Mahon, and Head R.A. Deahna Royster led the interested Crowell residents on a tour to see the work in progress on the second and third floors. DeTurk accompanied the residents and gave an account as to what happened the night of the fire. While on a round, he was radioed that there was a signal coming into

the security office from second floor Crowell. He got to Crowell as fast as possible. Upon arriving on the second floor, he saw smoke coming out from underneath the door of room 213. When he got to the door two people who he could not identify ran out. DeTurk asked the two people if there was anyone else in the room and they replied that ey did not know. DeTurk then preceded to ter the burning room to search for anyone else. Due to the thickness of the smoke, he had to reach up into the lofts because he could not see. At that point he radioed that it was indeed a real fire and to send for the fire engines. At the same time he began banging on doors and enlisting the help of other students to wake the rest of the dorm. He did not recall being on the third floor at all, but was later informed that indeed he had gone s along with other second floor res

The first floor has been in occupancy since November 26. Third floor may move back into the dorm as of December 18, but have the option to wait until Interim. Second floor is looking forward to moving back January 4.

called "white trash" by the black student who brought the complaint and called the black student a "nigger" in retaliation. In fact both parties agree that the racial harassment was unprovoked and occurred on more than on occasion. It has never been alleged in any responsible forum that the black student abused the white student verbally or nonverbally. The editorial reads like the distorted result of a game of "Gossip."

The editorial is also grossly irresponsible in its attempt to link the current case of racial harassment with a previous disciplinary case. The only similarity between the two cases is that the article attacks the black student in each instance. The minority student involved in an attempted rape was expelled after the administration received the first formal complaint. SGA has discussed the previous case at length with the Dean of Students and has been fully informed. As has been the policy of Albright with innumerable white perpetrators of attempted rapes, vandalism of the soccer field, beatings, and other serious offenses, unless a written complaint is filed and witnesses come forward, no College action can be taken.

In fact, no responsible organization can act based on rumor or unsubstantiated allegations--including a newspaper.

I know that faculty and administrators

are the Albrightian staff that its information was distorted and biased. The editors chose to print an article they had good reason to believe was false. In this case the Albrightian has apparently deliberately attempted to inflame racial hostility on campus and has in fact helped create a climate which invites abuse of minority students.

On such a sensitive issue the Albrightian had a special obligation to act responsibly. It failed miserably. I doubt that this editorial staff can reestablish a reputation for fairness and objectivity, but I urge it to try.

To the Editor:

As a member of the faculty I support the right of the Albrightian to report and to comment on all campus issues including, in most cases, the most controversial problems that may cause embarrassment to those in authority. But I was disappointed and angered by the inflammatory character of last week's editorial which managed to tar the concept and existence of diversity with a brush aimed at alleged policy inconsistencies in the Student Affairs office.

Diversity is not and should not be an issue at Albright College. As a community we

have been, we are and we will be committed to valuing all people as human beings for their differences, including those of social background, ethnic background, cultural heritage, and personal life style. This valuing means a welcoming and inclusion of different types of people into the social fabric of the college-including social organizations. Albright as a community does not expect merely to tolerate these people of different backgrounds but rather to grow and change as a community from an open interaction with them.

The editorial managed to insinuate that this commitment was itself the source of a problem, "Some of these social changes in policy interpretation and enforcement." According to the editorial, these vaguely hinted social changes that have somehow to do with diversity have "created an invisible monster that is beginning to take shape, form and most unfortunately color."

From the beginning, the editorial seems bent on fanning the flames of a vaguely defined controversy and suggesting that somehow this controversy is the result of diversity and ill-considered social change. From its provocative lead line, "The Campus is being tom apart physically and socially," to the emotionally laden language of "hideous" happenings, "invisible monsters" and free floating campus "fear," the editorial seeks to arouse controversy. This is, of course, much easier to do than allowing readers to understand the complexities of policy implementation regarding social infraction. However, when it comes to a real effort to examine the two cases upon which the charge of inconsistent implementation of policy rests, the editorial resorts to disclaimers of "limited information" and regretting "any discrepancies in what we feel are the facts."

In the mind of this reader the editorial did not have all the relevant facts of the two cases and therefore was not very successful in linking them together to form a charge of inconsistent application of social policy. What the editorial was successful at was creating the powerful impression that there is an invisible monster loose at Albright, a monster that has been unleashed by something called diversity.

This is not only nonsense—it is dangerous nonsense that can cause real and lasting damage to our community.

I am responding because the misinformation and distortions have too much potential to harm this valuable community.

Let me begin with the editorial's inference that the adminiatration is hiding facts from students. There's nothing to hide. But, it needs to be understood that students have the right to privacy and confidentiality. We cannot disclose the names of students who are being disciplined or victims of abuse who don't want to be identified. It is not our place to disclose such information and in fact as long as the judicial process to be in effect, it is a violation of a students rights to make comment on that being heard.

The second issue in the editorial I would like to address is the assertion that we allowed a student to remain on campus who had been involved in repeated sexual offenses. Not only is this inaccurate, it is a slanderous accusation. The student involved was reported once in a sexual abuse incident and as a result was expelled from Albright College.

The editorial also contended that a white student was "Fed Up" with being called

names with racial connotations (such as white trash) and used the term "nigger" once in retaliation. The truth by his own testimony is that the student was never called any names. Anyone who takes on the responsibility to write for the student newspaper (or any newspaper) must be responsible enough to check their facts. These distortion have the potential of polarizing the campus and this college community is too important not to care enough to be accurate; hearsay is unacceptable.

There are a number of other facts that are distorted, but, need not be detailed at this point. The Albrightian has almost always been responsible in the past and I am sure it will find its way back to that journalistic style. Thanks for letting me say my piece. My best for the holidays.

Dear Editor,

This letter is in response to the reaction to last week's Letter to the Editor from SGA. The sole intent of the letter was to examine the seeming inconsistencies in administrative policy. The examples used to illustrate the point were, to the best of the Student Government's knowledge, the most recent disciplinary actions taken by administration, and hence, the most logical cases in point. Since the last edition of The Albrig there has been a meeting between SGA and several members of the faculty and administration. The findings of this meeting included some surprisingly parallel intentions that were masked with poor communication and walls of fear. With the hopes of rectifying the situation, as well as preventing any furth discord, several members of the faculty and dministration have agreed to participate in bi-weekly meetings with SGA.

Another issue that needs to be addressed is the racism that is plaguing the college. We ask that everyone respect his or her fellow students, regardless of their race, creed, sexual orientation, or opion. Each student at this college is accepted for admission because he

The subplots add spice and humor to an otherwise dramatic script. McClain plays the nastiest woman in town. She is also the richest woman, but she looks and acts like a common slob. She is delightful as Weazer, the town complainer and nosybody. The most comedic lines and sight gags come from her character. The funniest line in the play is said after a fight with her best friend, played by Olympia Dukakis, the mayor's widow ar town socialite. She is trying to make up with Weazer when, when Weazer says, "You are evil. You must be destroyed." This should give you some insight into the mind of this

Dolly Parton is her wonderful sweet self. She doesn't stretch much in her acting abiliti but she looks great and plays the part of the town hairdresser with ease and raw charm. Her assistant is Darryl Hannah. This is the first movie that she has done since Splash that you don't think of her as a mermaid every time she is on screen.

All in all, this movie is a sad but witty tale of love and friendship. But more importantly it is a story about the strength and courage of women. Be prepared for a good cry. Campus Assaults on Pizza Deliverers

(CPS) - A rash of assaults on people attempting to deliver pizzas to students at Howard University has convinced some local pizza

places to stop bringing pizzas to campus.
"Two or three" assaults on pizza deliverers have been reported this semsester, said Lawrence Dawson, director of security at the Washington, D.C. college. "It's abnormal because we've had none of this in the past."

Pizza store owners, however, report more than "two or three" crimes against delivery people, citing instances of wrecked cars, physical attacks and robberies at least last March.

Police have no suspects, although some pizza sellers believe the assailants may be

Regardless of who the culprits are, the sellers are dismayed. Eric Adams, owner of a nearby Pizza Hut, drafted an open letter to Howard students at the end of October, pleading with them not to hurt his employees.

drivers' cars have been broken into and lights have been busted, Adams said, causing more than \$500 in damage since March.

Adams, who has a second restaurant that rves Gallaudet University in Washington, D.C., said his problems are limited to Howard.

No one at Pizza Hut headquarters in Wichita, Kansas, has heard of any similar problems at other campuses, said spokesman

It's a problem directed at all the operators coming into campus," Adams said.

A few stores already have dropped Howard

from their routes. Pizza Movers stopped deliveries after 2 drivers were assaulted in front of Howard Plaza. Another restaurant, Happy Pizza, suspended deliveries temporarily after a driver was assaulted and robbed trying to make a trip to Howard dorm last semester.

"If it's not possible for them to return to campus, the students will have to live with that decision," Howard's Dawson said.

I'll be missing my family, but not the holiday," she concluded.

Freshman Ovais Karim, a Business Administration major from Pakistan, explains that Christmas has no meaning for Muslims, so he will spend the holiday break sightseeing. Ovais plans to spend Christmas break with some friends in Chicago.

Similarly, the majority of people in Harmeet Sahani's native India are not Christian, but through Western influence celebrate Christmas anyway. According to Harmeet, in India there is "more emphasis on partying; Christmas is a week-long celebration, not so much concerned with gifts and Christmas trees." Harmeet, a junior Business/Computer Science major, has not been able to go home for Christmas break during any of his years at Albright. Instead, he explains with a smile, "I probably won't know where I'm going for Christmas until the last minute. I just go with whoever wants to take me along home with

Minako Miyata, a junior Psychology/ Business major, is from Japan, and is able to go home this year for the first time. She plans to spend the first part of break with a friend here in the States, and then they will go to her home at the end of the month. She explains that Christmas is also spent a little differently in Japan. Although they do have the trees, lights, and decorations, Japanese families generally do not exchange gifts. Christmas is "more a time for boyfriends and girlfriends to go our for a special dinner and then exchange gifts," Minako explains.

In Columbia, Christmas is celebrated virtually the same way as in the United States, according to junior Business(Marketing)/Communications major Claudia Rodriguez.

Like Minako, this is the first year that Claudia will be going home during Christmas break. She spent her first Albright Christmas with an uncle in Texas and celebrated the holiday last year with her roommate. "This is the we're really exchanging gifts," Claudia relates,





Lions Fall to Ursinus

Last Tuesday evening in the Bollman Gym, the Albright wrestling team went up against Ursinus College in their regular season match. Although Ursinus walked off the matt with a victory of 30 to 20 showing on the scoreboard, on thematt, the Lions surmounted their opponents. What killed us, as coach Cherrie eluded to in last week's preview article, were the two holes in the line-up, at the 118 lb. class and at 177. If one doesn't count these two forfiets, the Lions beat Ursinus in points earned on the matt 20-18.

In terms of individual performances, it looks like this: at 118, the forfeit; at 126 Hoffman was pinned, bringing Ursinus up to 12 points; in the 134 slot, Mike DeLuca won on points, putting Albright on the board with 5 points; at 142, John Gillespie was pinned, putting Albright back 13 points; Andrew Kelly, at 150, tacked another 4 points to Albright's total, giving them 9 to U.C.'s 18. Ward Weiland wrestled at 158, and gave Albright another 3, pulling Albright to within 6 points of Ursinus. A pin would tie up the

match, but Cherrie took a gamble, and moved Huw Price, Albright's 167 pounder, up to try his luck against Ursinus' 177 lb. wrestler. Cherrie probably did this because Price lost to U.C.'s 167 pounder in the tournament that opened up the season for Albright. So, we took the forfiet at 167, and, after leading the whole first period, and most of the second, Price was pinned by the stronger wrestler from Ursinus. These two incidents gave Ursinus. an insurmountable 18 point lead over the Lions, 30 to 12. At 190, Rockovich won on points adding 3 to the cause, and Chris Boylan got the job done at the heavy-weight spot, adding 5 more points, bringing the final score to Albright 20 Ursinus 30.

The major challange for the wrestling team this year isgoing to be keeping spirits up in the face of the inevitable up-hill battles they will have to wage due to the two holes in the squad's roster. Pruitt - "Wow!"

Since the semester is (finally) coming to a close, and we are being bombarded with finals, I'll just throw some sports tid bits your way.

Wow! That one word describes the play of Pat Pruitt against Delaware Valley College on Monday the eleventh. Pruitt's 34 points was the highest total by an Albright player in four years (Greg Swavely scored 37 against Gettysburg during the '85-'86 season). Pat was 15 of 16 from the free throw line (Pruitt missed a free throw - you had to see it to believe it), and from the field he hit 7 of 11, including nailing 5 of 6 from three point range. The Lions were down by 14 at one point in the first half. Then Pruitt got hot, sinking three bombs from what Ricketts usually terms the 5 point range, to give the Lions a 2 point lead going into halftime, 38-36. Ricketts insisted that I include Pruitt's 69% efficiency rate (fg's, ft's, and turnovers), which is one of the highest he has ever seen. The Lions had a team efficiency rate of 50%, and according to Ricketts, "that's why we won the game."

To the "seventh man" on the Lions, Jeff Silverstein. I have a message that Coach Ricketts asked me to deliver.
